STATEMENT UNDER GENERAL INSTRUCTION E TO FORM S-8

This registration statement registers an additional \$25,000,000 of deferred compensation obligations of Group 1 Automotive, Inc. ("Group 1"), to be offered and sold under the Group 1 Automotive, Inc. Deferred Compensation Plan. The contents of the previous registration statement on Form S-8 filed by Group 1 with the Securities and Exchange Commission (the "Commission") on February 22, 2002 (Registration No. 333-83260) (the "Prior Registration Statement") are incorporated by reference into this registration statement pursuant to General Instruction E to Form S-8 regarding registration of additional securities. The Prior Registration Statement incorporated herein by reference contains a consent of Arthur Andersen LLP, former independent public accountants to Group 1. We are unable to obtain the written consent of Arthur Andersen to the inclusion of their consent in this Registration Statement, and we have dispensed with the requirement to file their consent in reliance on Rule 437A promulgated under the Securities Act. Arthur Andersen has not consented to the inclusion of its report in this Registration Statement. Because of Arthur Andersen's current financial position, you may not be able to recover against Arthur Andersen for any claims you may have under securities or other laws as a result of Arthur Andersen's activities during the period in which it acted as our independent public accountants.
