(c) Appointment of Principal Officers

On April 23, 2007 Elizabeth Marie Reynolds, 41, was appointed Chief Accounting Officer of Capstone Turbine Corporation (the Company), effective April 30, 2007.

Ms. Reynolds most recently served as Controller North America (from January 2006) and Controller (from February 1998 to December 2005) of Spirent Communications, Inc., a global provider of performance analysis and service assurance that enables the development of next-generation networking technologies. Ms. Reynolds had been employed by Spirent Communications since December, 1995.

Ms. Reynolds will receive an annual salary of \$195,000 and a ten year stock option grant to purchase 110,000 shares of the Company's common stock at a purchase price of the fair market value of the Company's common stock at the close of market on April 23, 2007 with 25% vesting on the first anniversary date and monthly thereafter subject to the Company's 2000 Equity Incentive Plan. Ms. Reynolds also received a restricted stock grant of 30,000 restricted stock units subject to annual vesting of 25% and to the Company's 2000 Equity Incentive Plan.
