Item 8.01.           Other Items.

On June 24, 2005, Southern Connecticut Bancorp, Inc. ("Bancorp") announced the completion of its acquisition of real property located at 51-53 West Main Street, Clinton, Connecticut. The net purchase price of the property was \$495,000 and the transaction was completed in accordance with the terms of an Agreement of Sale previously filed as Exhibit 10.20 to Bancorp's Form 10-QSB dated November 15, 2004. Bancorp anticipates that the property will be used as a future branch office of the Bank of Southern Connecticut, a wholly owned subsidiary of Bancorp, subject to the receipt of various regulatory approvals, including the approval of the Federal Deposit Insurance Corporation and the State of Connecticut Department of Banking. A copy of the press release announcing the completed property acquisition is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
