## EXPLANATORY NOTE

1-800-Flowers.com, Inc. (“1-800-Flowers.com” or the “Registrant”) has prepared this Registration Statement in accordance with the requirements of Form S-8 under the Securities Act in connection with an amendment to the 2003 Plan (as amended as of October 28, 2011 and as approved by shareholders of the Registrant on December 12, 2011), which increased the number of shares of Class A Common Stock authorized for issuance under the 2003 Plan by 3,250,000 shares. The shares of Class A Common Stock previously available for issuance or transfer under the 2003 Plan are covered by a Registration Statement on Form S-8 (Registration No. 333-119999) previously filed by the Registrant on October 27, 2004, and a Registration Statement on Form S-8 (Registration No. 333-164727) previously filed by the Registrant on February 5, 2010 (collectively, the “Original Registration Statement”), which registers 14,643,686 shares of Class A Common Stock in the aggregate which, together with the shares of Class A common Stock registered under this Registration Statement, equals 17,893,686 shares of Class A Common Stock in the aggregate. Pursuant to General Instruction E to Form S-8, the contents of the Original Registration Statement, including the periodic and current reports that we filed with the Securities and Exchange Commission (the “Commission”) after the effectiveness of the Original Registration Statement, are incorporated herein by reference except to the extent supplemented, amended or superseded by the information set forth herein. Any items in the Original Registration Statement not expressly changed hereby shall be as set forth in the Original Registration Statement.
