HP COMMENTS ON COURT DECISION TO PROCEED  
ON HP-COMPAQ MERGER VOTING PROCESS COMPLAINT

PALO ALTO, Calif., April 8, 2002 -- Hewlett-Packard Company (NYSE:HWP) today made the following statement regarding a decision announced today by the Delaware Chancery Court to allow the complaint filed against HP by Walter Hewlett to proceed:

We respect the chancellor's decision to hear the evidence on the issues that have been raised. We remain confident, particularly based on the arguments presented, that once the facts are heard, we will prevail.

We remain optimistic we will be able to complete the merger on our current schedule. HP continues its progress in integration planning and looks forward to the receipt of the certified vote result from the HP shareowner meeting, which is expected within a few weeks.
