1. *I just read the Morningstar, Inc. annual report and on p. 72 I see there is revenue from Japan (about 0.7% of the total).*

Given that Morningstar Japan K.K. is not a wholly-owned consolidated subsidiary (it s an equity method affiliate), where are those Japan revenues on page 72 coming from? Are they from Ibbotson Japan, or some other entities?

You're correct that Morningstar Japan K.K. is an equity method affiliate; we own approximately 34% of the outstanding shares. The reported revenue from Japan reflects consulting revenue from Ibbotson Associates Japan.
