**Submission of Matters to a Vote of Security Holders**

Credo Petroleum Corporation (the Company) held its annual meeting (the Annual Meeting) of shareholders on April 5, 2012 at the Brown Palace Hotel in Denver, Colorado. A quorum consisting of approximately 90% of the Company's \$0.10 par value Common Stock issued and outstanding was represented either in person or by proxy. At the Annual Meeting, the Company's shareholders voted on proposals to: (1) elect James T. Huffman and Clarence H. Brown as directors to serve for three year terms; and (2) ratify the selection Ernst & Young as the Company's independent registered public accounting firm for fiscal year ending October 31, 2012

Voting results of the proposals are as follows:
