(1) equal annual installments over a three-year period with the initial vesting on April 1, 2015. Upon vesting, each restricted equity unit may be settled by delivery of one common unit of KKR & Co. L.P.

260,315 of these restricted equity units were previously granted to the Reporting Person and consist of 113,435 and 146,880 restricted  
(2) equity units of KKR & Co L.P., which will generally vest in equal annual installments over a two-year and three-year period, respectively, with the next vesting on April 1, 2014.
