(1) Each special warrant consists of one common share plus one common share purchase warrant. The special warrants will automatically convert into common stock and warrants upon shareholder approval, but in no event any later than December 15, 2010. The warrants are exercisable at \$3.50 for the first year, \$4.00 for the second year, \$4.50 for the third year and \$5.00 thereafter until the expiration date of October 21, 2015, subject to acceleration by the Issuer upon certain conditions.
