("BANA") and Blue Ridge Investments, L.L.C. ("Blue Ridge") of equivalent value in a cashless transaction. BANA and Blue Ridge collectively already hold 618 auction rate preferred securities of FMN.
- The Auction Rate Preferred Shares ("Shares") reported in Table I represent shares beneficially owned by BANA and Blue Ridge.

 BANA and Blue Ridge are wholly owned subsidiaries of Bank of America Corporation ("Bank of America").
