IMA'S OFFER TO AQUILINE IS REJECTED

IMA EXPLORATION INC. (IMR-AMEX, IMR-TSX.V). Mr. Joseph Grosso, President on behalf of the Board reports that Aquiline Resources Inc. has summarily rejected IMA's offer to settle the litigation claim involving IMA's Navidad Project.

IMA's offer was communicated to the Aquiline directors on September 29 at noon PST and Aquiline rejected the offer 24 hours later, on September 30 at noon PST. IMA's offer represented a value of approximately \$21,000,000 and upon acceptance could have appreciated substantially. The rejection of IMA's offer and the resulting protracted legal case, with no guarantee of success, will deprive Aquiline shareholders of the opportunity represented by IMA's offer and impose a heavy financial and management cost.

 ${\tt IMA}$ continues to assert that Aquiline has no claim whatsoever and we are fully prepared to vigorously defend this position.
