The acquisition resulted in additional effort to consolidate the financial results of RadioMobile and in the Company having to determine and allocate the fair value of the acquired assets.

For the October 31, 2007 fiscal year, net income decreased to \$1,135,000 compared to net income of \$1,541,000 for the prior fiscal year.
