(In this attachment, the numbers stated for first quarter 2005 are preliminary, as the financial review is not completed.)

Revenues in first quarter 2005 were \$3,580,849 compared to first quarter 2004 revenues of \$3,780,175 (a difference of \$199,326 or 5%).

Profit. In first quarter 2005 the Company had a profit of \$57,560, compared to a net loss of \$42,547 in first quarter 2004 (a difference of \$100,107). The profit was the result of improved gross margin.
