(1) On August 19, 2011, an aggregate of 2,189 restricted shares previously issued to Mr. Wright vested in accordance with their terms and the terms of the plan under which such shares were issued. Mr. Wright elected to withhold an aggregate of 716 shares to pay the related taxes. As such, the number of shares actually issued was 1,473.

(2) On August 20, 2011, an aggregate of 2,303 restricted shares previously issued to Mr. Wright vested in accordance with their terms and the terms of the plan under which such shares were issued. Mr. Wright elected to withhold an aggregate of 754 shares to pay the related taxes. As such, the number of shares actually issued was 1,549.
