- (1) There is no reportable change since the last filing. This is a reiteration of holdings only.

On 12/14/11 the reporting person was granted 159,212 restricted stock units ("RSUs"), 53,070 of which will vest on 12/12/12, and 53,071 (6) of which will vest on each of 12/12/13 and 12/12/14.
