The 379.6397 dividend equivalent rights being reported reflect 95.4428 dividend equivalent rights at \$23.26 per RSU credited to the reporting person's account on 04/04/12; 120.4142 dividend equivalent rights at \$20.28 per RSU credited to the reporting person's account on 07/05/12; and 163.7827 dividend equivalent rights at \$14.91 per RSU credited to the reporting person's account on 10/03/12.
