Dividend equivalent rights accrue with respect to these PARSUs when and as dividends are paid on HP common stock.

(7) On 12/11/13 the reporting person was granted 44,461 restricted stock units ("RSUs"), 14,820 of which will vest on each of 12/11/14 and 12/11/15, and 14,821 of which will vest on 12/11/16. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
