Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 1,674 vested dividend equivalent rights and a de minimus adjustment of 0.7260 due to fractional rounding of the dividend equivalent rights.
