The stock withholding transaction did not occur and instead there was an open market sale of 194 shares upon vesting of 25% of a restricted stock award granted on August 21, 2006. As a result of this mistake, the reporting person's holdings were overreported by 9 shares in three subsequent Form 4 filings
