On June 16, 2014, RBS made a capital contribution of \$16,800,000 to SPE I, resulting in the acquisition by RBS of an approximate 12.9% general partner interest in SPE I. Each of RBS, ESL and Mr. Lampert disclaims beneficial ownership of the securities owned by SPE I except to the extent of the pecuniary interest of RBS, ESL and Mr. Lampert, respectively, therein.
