Fair market value was established by comparing the volume weighted average share price measured on 8/28/14, the day before the ex-dividend date (\$60.5792), with that measured on 8/29/14, the ex-dividend date (\$57.5973). The number of stock options subject to each award was increased as necessary to ensure the total intrinsic value of the award was the same immediately before and immediately after the adjustment.
