- (1) Vests in 8 equal quarterly installments on the last day of each quarter from June 30, 2008 through March 31, 2010.

- (3) Vests in 16 equal quarterly installments on the last day of each quarter from March 31 2006 through December 31, 2009.
- (4) Vests in full on February 16, 2005.
- (5) 50% vests on September 8, 2004, the remaining 50% vests in 8 equal quarterly installments of 6.25%, beginning as of December 31, 2004, until fully vested.
- (6) Option vests in 16 equal quarterly installments of 6.25%, beginning as of December 31, 2003, until fully vested.
