Unilever NV and Unilever PLC - Transactions in Own Shares

Unilever NV announces that on 9 November 2005, it purchased 120,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 56.70 and euro 56.90 per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever NV together with subsidiary companies, holds 21,965,611 Unilever NV ordinary shares in treasury, and has 549,610,289 Unilever NV ordinary shares in issue (excluding treasury shares).

Unilever PLC announces that on 9 November 2005, it purchased 700,000 Unilever PLC ordinary shares at prices between 561.00 pence and 564.50 pence per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever PLC holds 11,091,991 Unilever PLC ordinary shares in treasury, and has 2,900,366,589 Unilever PLC ordinary shares in issue (excluding treasury shares).
