Unilever NV also announces that 10,276 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 92,933,123 Unilever NV ordinary shares in treasury, and has 1,621,794,577 Unilever NV ordinary shares in issue (excluding treasury shares).
