#### DEREGISTRATION OF SECURITIES

On July 20, 2001, the Securities and Exchange Commission (the SEC) declared effective the registration statement on Form S-3 (File No. 333-65538) (the Registration Statement) filed by Red Hat, Inc. (the Company) with respect to the resale on a continuous or delayed basis of an aggregate of 41,948 shares of common stock, par value 0.0001 per share, of the Company (the Shares), issued in connection with the Company s acquisition of Akopia, Inc. (Akopia).

The Registration Statement was filed for the benefit of holders of the Shares (the Holders ).

In connection with the acquisition, the Company agreed with Akopia to keep the Registration Statement effective until the earlier of (1) the date on which each of the Shares has been disposed of in accordance with the Registration Statement; and (2) the first anniversary of effective time of the acquisition. The Company is no longer obligated to keep the Registration Statement effective.

In accordance with such agreement, and in accordance with the Company s undertaking under Regulation S-K Item 512(a)(3), the Company is filing this Post-Effective Amendment No. 1 to the Registration Statement to remove from registration all Shares not sold by the Holders pursuant to the Registration Statement. Accordingly, the Company hereby requests that upon the effectiveness of this Post-Effective Amendment No. 1, such Shares be removed from registration.
