#### <u>Item 1</u>. <u>Security and Issuer</u>.

This Amendment No. 2 (the <u>Second Amendment</u>) amends the initial Schedule 13D (the <u>Schedule</u> 13D) filed on November 10, 2008, with the Securities and Exchange Commission (the <u>SE</u>C), as amended by Amendment No. 1 filed on November 13, 2008, by the Reporting Persons (as defined in the Schedule 13D), with respect to the common stock, par value \$0.0001 per share (<u>Common Stock</u>), of Delta Air Lines, Inc. (<u>Delta or the Issuer</u>). Capitalized terms used but not otherwise defined in this Second Amendment have the meanings ascribed to such terms in the Schedule 13D.

#### <u>Item 5</u>. <u>Interest in Securities of the Issuer</u>.

The third paragraph of Item 5 in the Schedule 13D is hereby deleted and replaced as follows:

On March 5, 2009, all unreserved Pilot Shares were distributed to the benefit plan accounts of the Eligible Pilots to the extent permitted by law and any remainder was distributed directly to Eligible Pilots. By that date, all investment services required to be performed by Athena were completed and, therefore, Athena no longer had investment power with respect to any shares held by ALPA. For services rendered as of March 5, 2009, Athena earned 570,036 shares of Common Stock.
