**Explanatory Statement**

This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-3 (File No. 333-91570) previously filed by Chordiant Software, Inc., a Delaware corporation (the Registrant), on June 28 2002, and as subsequently amended, pertaining to the registration of shares (the Shares) of the Registrant's common stock, par value \$0.001 per share (the Common Stock), in connection with the resale of the Shares by Canadian Imperial Holdings Inc.
