- (1) This grant was made pursuant to the issuer's non-employee director compensation policy. As a continuing director, the Reporting Person was awarded a number of shares equal to \$80,000 divided by \$10.25, the closing price of the issuer's common stock on the date of the grant, May 14, 2009. The shares underlying this restricted stock award will vest in full on the earlier of (i) May 14, 2010 or (ii) the date immediately preceding the date of the issuer's 2010 annual meeting of stockholders.
- (2) Price reflected is the weighted-average sale price for shares sold. The range of sale prices for the transactions reported was \$10.52 to \$10.58 per share. The reporting person undertakes to provide, upon request by the SEC staff, the issuer, or a security holder of the issuer, full information regarding the number of shares sold at each separate price.
- (3) These shares are held by Asheem Chandna and Aarti Chandna, as Trustees of the Chandna Family Revocable Trust of April 13, 1998. Aarti Chandna has voting and investment control with respect to the shares held by the trust.
