- (2) Of these shares, LSPEP directly holds 43,424,224 shares, PIE I directly holds 26,331,323 shares, and Gen Investors directly holds 1,033,294 shares.
- (3) Of these shares, LSPEP sold 481,104 shares, PIE I sold 291,728 shares and Gen Investors sold 11,448 shares.
- (4) Of these shares, LSPEP directly holds 42,943,120 shares, PIE I directly holds 26,039,595 shares, and Gen Investors directly holds 1,021,846 shares.

("Gen Investors"). As a result of its relationship with LSPEP, PIE I, and Gen Investors, LSP Partners may be deemed to have shared voting and investment power to the shares beneficially owned by LSPEP, PIE I, and Gen Investors. As such, LSP Partners may be deemed to have shared ownership of the shares of which LSPEP, PIE I, and Gen Investors are the owners. LSP Partners, however, disclaims beneficial ownership of such shares except to the extent of its pecuniary interest therein.
