(1) This grant was made pursuant to the issuer's non-employee director compensation policy. As a continuing director, the Reporting Person was awarded a number of shares equal to \$100,000 divided by \$24.32, the closing price of the issuer's common stock on the date of the grant, May 26, 2011. The shares underlying this restricted stock award will vest in full on the earlier of (i) May 26, 2012 or (ii) the date immediately preceding the date of the issuer's 2012 annual meeting of stockholders.

(2) In accordance with the issuer's non-employee director compensation policy, shares were issued in lieu of the quarterly cash payment of board and committee retainer fees at the election of the Reporting Person. The number of shares is equal to \$10,000 divided by \$24.32, the closing price of the issuer's common stock on the date of the grant. The shares underlying this restricted stock award were vested in full upon grant.

(3) Shares are held by the Guleri Family Trust UTD dated April 7, 1999 (the "Guleri Trust"). The Reporting Person is a trustee and beneficiary of the Guleri Trust.
