317,000 market based performance restricted shares were granted subject to the Company's stock price achieving an average specified price over 60 trading days and subject to Mr. Clarke's continued employment through specified dates. The compensation committee (1) determined on January 23, 2014 that the market based performance criteria had been met. 105,667 of these shares vested on January 23, 2014. The remaining shares will vest 105,667 on December 31, 2014 and 105,666 shares will vest on December 31, 2015, both contingent on continued employment through the vesting date.
