*Subject to the Ownership Limitation (defined below), the Reporting Persons may be deemed to beneficially own a total of 16,541,353 shares of Common Stock issuable upon conversion of a 10% OID Convertible Note Due January 1, 2015 ("Note") issued to Gemini Master Fund, Ltd. ("Gemini") in the original principal amount of \$220,000 (assuming no interest accrual and a conversion price of \$0.0133).

In accordance with Rule 13d-4 under the Securities Exchange Act of 1934, as amended, because the number of shares of Common Stock into which the Note is convertible is limited, pursuant to the terms of such instrument, to that number of shares of Common Stock which would result in the Reporting Persons having beneficial ownership of

9.99% of the total issued and outstanding shares of Common Stock (the "Ownership Limitation"), the Reporting Persons disclaim beneficial ownership of any and all shares of Common Stock that would cause any Reporting Person's beneficial ownership to exceed the Ownership Limitation. Therefore, in accordance with the Ownership Limitation, based upon 39,359,330 shares of Common Stock outstanding, each of the Reporting Persons beneficially owns 4,368,400 shares of Common Stock and disclaims beneficial ownership of 12,172,953 shares of Common Stock.

In addition, as permitted by Rule 13d-4, the filing of this statement shall not be construed as an admission that Gemini Strategies LLC, Inc., in its capacity as investment manager for Gemini, is the beneficial owner of the Note, or that Steven Winters, in his capacity as president or principal of Gemini Strategies LLC, Inc., is the beneficial owner of the Note. Each of Gemini Strategies LLC, Inc. and Steven Winters expressly disclaims any equitable or beneficial ownership of the Note.
