 The number of shares underlying stock appreciation rights will be determined at the time of exercise by calculating the difference between the closing price of Casade common stock on the date of exercise and the base price of the stock appreciation rights established at the time of grant (see column 2), multiplying that figure by the number of stock appreciation rights held by the reporting person, and then dividing the product by the closing price of Cascade common stock on the date of exercise.
