(1) The exercise and sale reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on May 27, 2010.

(2) This non-qualified employee stock option grant and its companion incentive option grant, together totaling 265,000 options, were granted to the reporting person on 10/1/2008. On 10/1/2009, 25% of the shares from the grants vested and became exercisable. The remaining 75% of the shares began vesting in 36 equal monthly installments on 11/1/2009. The 5,521 shares reported on this Form 4 vested on 9/1/2010.
