The price reported in Table I - Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$32.82 to \$32.87. The option vests on a 4-year schedule: 25% of the shares became exercisable on 2/3/2011; the remaining 75% of the shares vested at a rate of 1/36th per month over the following 36 months so that the option was fully vested and exercisable on 2/3/2014. Only vested shares can be exercised under this option.
