"América Móvil announces a proposal for a dividend payment"

Mexico City, Mexico, February 14, 2012 -- América Móvil, S.A.B. de C.V. (<u>"AMX"</u>) (BMV: AMX; NYSE: AMX; NASDAQ: AMOV; LATIBEX: XAMXL), announced that in today's meeting, its Board of Directors decided to submit to the Ordinary General Shareholders' Meeting to be held on or before April 30, 2012, a proposal to make a payment of a cash dividend from the consolidated net profit tax account (*cuenta de utilidad fiscal neta consolidada*), of *MXP\$0.20* (twenty peso cents), payable in two installments, to each of the shares of its capital stock series "AA", "A" and "L" outstanding as of the date of the dividend payment (which includes the preferred dividend correspondent to the series "L" shares), subject to adjustments arising from other corporate events (including repurchase or placement of its own shares), that may vary the number of shares outstanding as of the date of such dividend payment.
