**Item 7.01 Regulation FD Disclosure.**

The J. M. Smucker Company (the "Company") today announced the signing of a definitive agreement to acquire a majority of the North American foodservice coffee and hot beverage business of Sara Lee Corporation ("Sara Lee"), a leading international coffee and tea company. The acquisition includes Sara Lee's market-leading liquid coffee concentrate business sold under the licensed Douwe Egberts® brand, along with a variety of roast and ground coffee, cappuccino, tea, and cocoa products, sold through foodservice channels in North America. In addition, the companies agreed to collaborate on liquid coffee technology by entering into a long-term foodservice innovation partnership. Attached as Exhibit 99.1 and incorporated by reference into this Item 7.01 is a copy of the press release issued by The J. M. Smucker Company, dated October 24, 2011.
