(1) The reporting person no longer has a reportable beneficial interest in 48 shares of common stock owned by his son and included in the reporting person's prior ownership reports.

On February 14, 2019, the Compensation Committee amended the option to grant a 30 day window to exercise up to 40% of this option, with any shares issued upon exercise to be held as restricted stock until 2/9/22, the original date exercisable. The grant and exercise of these stock options are exempt from Section 16(b) pursuant to Rule 16b-3(d).
