Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a whollyowned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 27,977,134 shares or 14.867% of the Common Stock outstanding of SANDRIDGE ENERGY INC ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of SANDRIDGE ENERGY INC owned by the investment companies at August 31, 2009 included 4,381,904 shares of Common Stock resulting from the assumed conversion of 351,100 shares of SANDRIDGE ENGY 8.5 PRP PC (12.4805 shares of Common Stock for each share of Convertible Preferred Stock).

Edward C. Johnson 3d and FMR LLC, through its

control of Fidelity, and the funds each has sole power to dispose of the 27,977,134 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d, Chairman of FMR LLC, has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Pyramis Global Advisors, LLC ("PGALLC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 225,898 shares or 0.120% of the outstanding Common Stock of SANDRIDGE ENERGY INC as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning such shares. The number of shares of Common Stock of SANDRIDGE ENERGY INC owned by the institutional account(s) at August 31, 2009 included 225,898 shares of Common Stock resulting from the assumed conversion of 18,100 shares of SANDRIDGE ENGY 8.5 PRP PC (12.4805 shares of Common Stock for each share of Convertible Preferred

Edward C. Johnson 3d and FMR LLC, through its control of PGALLC, each has sole dispositive power over 225,898 shares and sole power to vote or to direct the voting of 225,898 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Pyramis Global Advisors Trust Company ("PGATC"),
900 Salem Street, Smithfield, Rhode Island, 02917, an indirect
wholly-owned subsidiary of FMR LLC and a bank as defined
in Section 3(a)(6) of the Securities Exchange Act of 1934, is
the beneficial owner of 23,713 shares or 0.013% of the
outstanding Common Stock of the SANDRIDGE ENERGY
INC as a result of its serving as investment manager of
institutional accounts owning such shares. The number of
shares of Common Stock of SANDRIDGE ENERGY INC
owned by the institutional account(s) at August 31, 2009
included 23,713 shares of Common Stock resulting from the
assumed conversion of 1,900 shares of SANDRIDGE ENGY
8.5 PRP PC (12.4805 shares of Common Stock for each share

of Convertible Preferred Stock).

Edward C. Johnson 3d and FMR LLC, through its control of Pyramis Global Advisors Trust Company, each has sole dispositive power over 23,713 shares and sole power to vote or to direct the voting of 23,713 shares of Common Stock owned by the institutional accounts managed by PGATC as reported above.
