On December 27, 2011, the reporting person exercised 50,000 stock options, delivered 7,864 shares of common stock of the Company for cancellation in partial payment of the exercise price of such options and had 13,006 shares of common stock of the Company withheld (1) and cancelled to cover minimum required tax withholding.
