Linked to a Basket of Three Exchange-Traded Funds due September 8, 2020

The Basket will consist of three exchange-traded funds (each, a "Basket Component"): the SPDRS&P 500[®] ETF

- ·Trust (the "SPY") (60%), the iShar@sRussell 2000 ETF (the "IWM") (20%) and the SPDRS&P MidCap 400® ETF Trust (the "MDY") (20%).
- Unlike ordinary debt securities, the Securities do not pay interest or repay a fixed amount of principal at maturity.
- ·Instead, the Securities provide for a Payment at Maturity that may be greater than, equal to or less than the Principal Amount of the Securities, depending on the performance of the Basket from the Initial Level to the Final Level. The Payment at Maturity will reflect the following terms:

o If the level of the Basket increases:

You will receive the Principal Amount plus 150% participation in the upside performance of the Basket, subject to the Maximum Redemption Amount of 140% to 145% (to be determined on the Pricing Date) of the Principal Amount of the Securities

o If the level of the Basket is flat or decreases but the decrease is not more than 10%:

You will be repaid the Principal Amount

o If the level of the Basket decreases by more than 10%:

You will receive less than the Principal Amount and will have 1-to-1 downside exposure to the decrease in the level of the Basket in excess of 10%

Hypothetical Payout Profile

The profile to the right is based on a hypothetical Maximum Redemption Amount of 142.50% or \$1,425.00 per \$1,000 Principal Amount (the midpoint of the specified range for the Maximum Redemption Amount), the Leverage Factor of 150% and a Buffer Level equal to 90% of the Initial Level.

How the Payment at Maturity is Calculated

The Payment at Maturity will be determined as follows:

- · If the Percentage Change is **positive**, then the investor will receive an amount per Security equal to the lesser of:
 - (i) Principal Amount + (Principal Amount x Percentage Change x Leverage Factor); and (ii) the Maximum Redemption Amount.
 - If the Percentage Change is **less than or equal to 0% but greater than or equal to -10%**, then the investor will receive an amount per Security equal to the Principal Amount.

If the Percentage Change is **less than -10%**, then the investor will receive less than the Principal Amount per Security, calculated using the following formula:

Principal Amount + [Principal Amount x (Percentage Change + Buffer Percentage)]

If the Final Level is less than Buffer Level, the investor will receive less, and possibly 90% less, than the Principal Amount of the Securities at maturity.

Hypothetical Values of the Basket*

* While actual historical information on the Basket will not exist before the Pricing Date, the graph above sets forth the hypothetical daily performance of the Basket from January 2, 2008 through August 1, 2016. The graph is based upon actual daily historical closing prices of the Basket Components and a hypothetical Basket level of 100.00 as of January 2, 2008. The dotted line presents the Buffer Level of 90.00, which is equal to 90% of the Initial Level of 100, which will be set on the Pricing Date.
