## General

The notes are designed for investors who seek an unleveraged return equal to any appreciation (up to the Maximum - Upside Return of $7.00 \%$ ), or an unleveraged return equal to the absolute value of any depreciation (up to $18.40 \%$ ), of the S\&P $500^{\circledR}$ Index at maturity.
Investors should be willing to forgo interest and dividend payments and, if the Ending Index Level is less than the Initial Index Level by more than $18.40 \%$, be willing to lose some or all of their principal amount at maturity.
The notes are unsecured and unsubordinated obligations of JPMorgan Chase Financial Company LLC, which we refer to as JPMorgan Financial, the payment on which is fully and unconditionally guaranteed by JPMorgan Chase \& Co. Any payment on the notes is subject to the credit risk of JPMorgan Financial, as issuer of the notes, and the credit risk of JPMorgan Chase \& Co., as guarantor of the notes.

## What Is the Total Return on the Notes at Maturity, Assuming a Range of Performances for the Index?

## Hypothetical Examples of Amount Payable at Maturity

The following examples illustrate how the total payment at maturity in different hypothetical scenarios is calculated.
Example 1: The level of the Index increases from the Initial Index Level of 2,900 to an Ending Index Level of 2,972.50.

Because the Ending Index Level of 2,972.50 is greater than the Initial Index Level of 2,900 and the Index Return of $2.50 \%$ does not exceed the Maximum Upside Return of $7.00 \%$, the investor receives a payment at maturity of $\$ 1,025$ per $\$ 1,000$ principal amount note, calculated as follows:
$\$ 1,000+(\$ 1,000 \times 2.50 \%)=\$ 1,025$

Example 2: The level of the Index decreases from the Initial Index Level of 2,900 to an Ending Index Level of 2,755.

Although the Index Return is negative, because the Ending Index Level of 2,755 is less than the Initial Index Level of 2,900, which does not exceed the Contingent Buffer Amount of $18.40 \%$, and the Absolute Index Return is $5.00 \%$, the investor receives a payment at maturity of $\$ 1,050$ per $\$ 1,000$ principal amount note, calculated as follows:
$\$ 1,000+(\$ 1,000 \times 5 \%)=\$ 1,050$
Example 3: The level of the Index increases from the Initial Index Level of 2,900 to an Ending Index Level of 3,770.

Because the Ending Index Level of 3,770 is greater than the Initial Index Level of 2,900 and the Index Return of 30\% exceeds the Maximum Upside Return of $7.00 \%$, the investor receives a payment at maturity of $\$ 1,070$ per $\$ 1,000$ principal amount note, the maximum payment at maturity if the Index Return is positive.

## Example 4: The level of the Index decreases from the Initial Index Level of 2,900 to an Ending Index Level of 1,450.

Because the Ending Index Level of 1,450 is less than the Initial Index Level of 2,900 by more than the Contingent Buffer Amount of $18.40 \%$ and the Index Return is $-50 \%$, the investor receives a payment at maturity of $\$ 500$ per $\$ 1,000$ principal amount note, calculated as follows:
$\$ 1,000+(\$ 1,000 \times-50 \%)=\$ 500$
Example 5: The level of the Index decreases from the Initial Index Level of 2,900 to an Ending Index Level of 2,366.40. Although the Index Return is negative, because the Ending Index Level of 2,366.40 is less than the Initial Index Level of 2,900 by up to the Contingent Buffer Amount of $18.40 \%$ and the Absolute Index Return is $18.40 \%$, the investor receives a payment at maturity of $\$ 1,184.00$ per $\$ 1,000$ principal amount note, the maximum payment at maturity if the Index Return is negative, calculated as follows:
$\$ 1,000+(\$ 1,000 \times 18.40 \%)=\$ 1,184.00$

The hypothetical returns and hypothetical payments on the notes shown above apply only if you hold the notes for their entire term. These hypotheticals do not reflect fees or expenses that would be associated with any sale in the secondary market. If these fees and expenses were included, the hypothetical returns and hypothetical payments shown above would likely be lower.

## Selected Purchase Considerations

CAPPED, UNLEVERAGED APPRECIATION POTENTIAL IF THE INDEX RETURN IS POSITIVE - The notes provide the opportunity to earn a capped, unleveraged return equal to a positive Index Return, up to the Maximum Upside Return of $7.00 \%$. Accordingly, the maximum payment at maturity if the Index Return is positive is . $\$ 1,070$ per $\$ 1,000$ principal amount note. Because the notes are our unsecured and unsubordinated obligations, the payment of which is fully and unconditionally guaranteed by JPMorgan Chase \& Co., payment of any amount on the notes is subject to our ability to pay our obligations as they become due and JPMorgan Chase \& Co.'s ability to pay its obligations as they become due.
POTENTIAL FOR UP TO A $18.40 \%$ RETURN ON THE NOTES EVEN IF THE INDEX RETURN IS
NEGATIVE - If the Ending Index Level is less than the Initial Index Level by up to the Contingent Buffer Amount, you will earn a positive, unleveraged return on the notes equal to the Absolute Index Return. Under these circumstances, you will earn a positive return on the notes even though the Ending Index Level is less than the Initial Index Level. For example, if the Index Return is -5\%, the Absolute Index Return will equal 5\%. Because the payment at maturity will not reflect the Absolute Index Return if the Ending Index Level is less than the Initial Index Level by more than the Contingent Buffer Amount of $18.40 \%$, your maximum payment at maturity if the Index Return is negative is $\$ 1,184.00$ per $\$ 1,000$ principal amount note.
RETURN LINKED TO THE S\&P 500 ${ }^{\circledR}$ INDEX - The return on the notes is linked to the S\&P 5@Index. The S\&P $500^{\circledR}$ Index consists of stocks of 500 companies selected to provide a performance benchmark for the U.S. equity markets. For additional information about the S\&P $500^{\circledR}$ Index, see "Equity Index Descriptions - The S\&P U.S. Indices" in the accompanying underlying supplement.
TAX TREATMENT - You should review carefully the section entitled "Material U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 4-I. The following discussion, when read in combination with that section, constitutes the full opinion of our special tax counsel, Latham \& Watkins LLP, regarding the material U.S. federal income tax consequences of owning and disposing of notes.
Based on current market conditions, in the opinion of our special tax counsel it is reasonable to treat the notes as "open transactions" that are not debt instruments for U.S. federal income tax purposes, as more fully described in "Material U.S. Federal Income Tax Consequences - Tax Consequences to U.S. Holders - Notes Treated as Open Transactions That Are Not Debt Instruments" in the accompanying product supplement. Assuming this treatment is respected, the gain or loss on your notes should be treated as long-term capital gain or loss if you hold your notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the IRS or a court may not respect this treatment, in which case the timing and character of any income or loss on the notes could be materially and adversely affected. In addition, in 2007 Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments. The notice focuses in particular on whether to require investors in these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by non-U.S. investors should be subject to withholding tax; and whether these instruments are or should be subject to the "constructive ownership" regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income and impose a notional interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the notes, possibly with retroactive effect. You should consult your tax adviser regarding the U.S. federal income tax consequences of an investment in the notes, including possible alternative treatments and the issues presented by this notice.

Section $871(\mathrm{~m})$ of the Code and Treasury regulations promulgated thereunder ("Section $871(\mathrm{~m})$ ") generally impose a $30 \%$ withholding tax (unless an income tax treaty applies) on dividend equivalents paid or deemed paid to Non-U.S. Holders with respect to certain financial instruments linked to U.S. equities or indices that include U.S. equities. Based on certain determinations made by us, we expect that Section $871(\mathrm{~m})$ will not apply to the notes with regard to Non-U.S. Holders. Our determination is not binding on the IRS, and the IRS may disagree with this determination. Section $871(\mathrm{~m})$ is complex and its application may depend on your particular circumstances, including whether you enter into other transactions with respect to an Underlying Security. If necessary, further information regarding the potential application of Section $871(\mathrm{~m})$ will be provided in the pricing supplement for the notes. You should consult your tax adviser regarding the potential application of Section $871(\mathrm{~m})$ to the notes.

Withholding under legislation commonly referred to as "FATCA" may (if the notes are recharacterized as debt instruments) apply to amounts treated as interest paid with respect to the notes, as well as to payments of gross proceeds of a taxable disposition, including redemption at maturity, of a note, although under recently proposed regulations (the preamble to which specifies that taxpayers are permitted to rely on them pending finalization), no withholding will apply to payments of gross proceeds (other than any amount treated as interest). YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS - The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. If the Ending Index Level is less than the Initial -Index Level by more than the Contingent Buffer Amount of $18.40 \%$, you will lose $1 \%$ of the principal amount of your notes for every $1 \%$ that the Ending Index Level is less than the Initial Index Level. Accordingly, under these circumstances, you will lose more than $18.40 \%$ of your principal amount at maturity and may lose all of your principal amount at maturity.
