ISSUE OF COMMERCIAL PAPER AND PROMISSORY NOTE

China United Network Communications Corporation Limited (CUCL), a wholly-owned subsidiary of China Unicom (Hong Kong) Limited (the Company), has completed the issue of the first tranche of commercial paper for the year 2010 of an amount of RMB15 billion and the issue of the first tranche of promissory note for the year 2010 of an amount of RMB3 billion.

Reference is made to the announcements made by the Company on 23 March 2010 and 25 March 2010.

The Company announces that CUCL, a wholly-owned subsidiary of the Company, completed the issue of the first tranche of commercial paper for the year 2010 of an amount of RMB15 billion on 1 April 2010, with a maturity period of 365 days and at an interest rate of 2.64% per annum.
