ANNOUNCE APPROVAL OF REORGANIZATION

CHICAGO (September 23, 2005) -- Van Kampen Asset Management announced today that the shareholders of Van Kampen Municipal Income Trust (NYSE/CHX: VMT) approved the reorganization of VMT into Van Kampen Trust for Investment Grade Municipals (NYSE/CHX: VGM) at a special meeting of shareholders held on September 23, 2005. In the reorganization, shareholders of VMT will receive newly issued shares of VGM. The transaction is currently expected to close on or about October 7, 2005, subject to the satisfaction of certain conditions.
